\$10,000 Hole-in-one Made at the Preserve Our Forest Golf Tournament

brilliant blue, cloud-free sky and a high of 49°F made for a spectacular day of golf on Sunday, December 9, 2017 for the sixth annual Preserve Our Forest Golf Tournament to benefit The Walthour-Moss Foundation. Seventy-four golfers, a record for the tournament, teed off just before noon at the historic Donald Ross Mid-Pines Country Club course in Southern Pines.

An hour into the tournament Rick Finnin, playing on the Banixx Horse and Pet Care team, struck gold by sinking a 164 yard hole-in-one on Hole 2 to win the \$10,000 hole-inone prize. Mr. Finnin's amazing shot, combined with other great shots made by team members Bob DeMeulemester, Doug English, and Perry Johnson, secured the tournament win for the Banixx team with a score of forty-five.

Second place went to Matt Oldroyd, Rob Carpenter, Leighton Schwob, and Rob Thomas in a tie breaker over three other teams. Jeremy Musgrave took home the prize for the longest drive on Hole 1 and Todd Phillips was closest to the pin on Hole 11.

At registration, each golfer was given a WMF logo pint glass stuffed with chocolates, candy canes, and WMF poker chip ball markers. A drawing for door prizes sent most players home with additional loot. Door prizes included green and cart fees from various local golf courses, wine from Bacco Selections, a gift certificate for dinner at The Sly Fox, cookies from Sweety Sweet Bakeries, dinner at Vito's Pizzeria of Pinehurst, and pottery from Irene Russell to name a few. 2018 PRESCRIBED BURN PLAN

The Walthour-Moss Foundation will conduct prescribed burns on approximately 900 acres in 2018. Our prescribed burn teams started burning in late January and will continue through June. On burn days, we will send an email notice along with a map of the area, post the information on our Facebook page and post notices at major Foundation entrances. For your safety, we request that you do not ride, walk or drive through the burn area while it is being burned or for several days after the burn.


WMF turns 40 in 2018

2018 marks the fortieth anniversary of the first gift of land received by The Walthour-Moss Foundation and forty years of focusing on our mission to preserve open land, protect and improve wildlife habitat and provide a place for equestrian purposes.

In the early 1970s, at a time when many people their age were thinking of and planning for retirement, Virginia Walthour "Ginnie" Moss and William Ozelle "Pappy" Moss were making plans to forever preserve the land they had owned and stewarded for more than thirty years. They chose to create a nonprofit corporation to make the land available to the public and to give the organization the ability to receive tax-deductible contributions for both expansion and maintenance.

Pappy Moss died in 1976 but his legacy lives on. On March 22, 1978, The Walthour-Moss Foundation received a deed to 1,739 acres of land, a bequest from Pappy's estate, which became the first tract of land to be owned by The Walthour-Moss Foundation. Ginnie Moss subsequently donated an additional 717 acres of open land during her lifetime to The Walthour-Moss Foundation and upon her death in 2006 left a bequest of another 114 acres.

We are forever grateful to Ginnie and Pappy Moss for creating The Walthour-Moss Foundation and for instilling the importance of land preservation in our equestrian community and we are proud to be celebrating forty years of land preservation in 2018.
